



Information for Institute Level Counselling Round (ACAP) for Direct Second Year Engineering (DSE) Admission 2024-25

Institute Level Counselling Round (ACAP) against vacant seats at WCE after CAP-III will be carried out as per the inter-se-merit.

1. Candidates who have applied to the Competent Authority for verification of document & received confirmed application Id number DSE24----- have to submit filled application form for Institute Level Counselling Round (ACAP) on 14/09/2024 between 10.30 am to 2.00 pm.
2. Candidate pays Rs. 800 towards processing fee for Institute level round (Non-refundable).
3. Alongwith Filled application form, attach receipt of processing fee (Rs.800/-), Acknowledgement from Facilitation centre, print of Final State Merit status & Copy of Admission letter.
4. Candidate having Receipt of CVC/NCL/EWS are eligible within respective category only after producing fresh Acknowledgement issued by concern Scrutiny Centre having information of uploaded required document (if applicable). Otherwise, such candidates will be considered in open category; provided the candidate fulfills the open category eligibility.
5. The application-processing fee for Institute Level Counselling Round (ACAP) is Rs. 800/- (INR Eight hundred only) (Non-refundable). The Candidates have to pay this fee through online mode only by scanning following QR code / bank account details.
6. The processing fee for Institute Level Counselling Round (ACAP) is Rs. 800/- (INR Eight hundred only) (Non-refundable) is to be paid only via UPI.
7. Vacant Seats after reporting of CAP III, as on 10/09/2024 up to 5.00 pm or last date published by CET cell for Institute Level Counselling Round (ACAP) of Direct Second year degree(DSE) of undergraduate technical courses in Engineering and Technology at Walchand College of Engineering, Sangli for academic year 2024-25, will be published on

11/09/2024 at 12.15 pm on WCE website. It may vary at the time of Institute counselling round.

11. Admitted candidates in ACAP at WCE have to submit/ produce their original documents/Admission letter issued from CET cell / bonafide certificate/ original payment receipt at Counselling round.

12. If candidate of higher WCE institute round merit, reports late during the process of counselling, the candidate may be considered for allotment of a seat available at that point of time for an eligible vacancy. Such a candidate shall be given preference for admission over the candidates with lower rank present at that point of time. The decision of the Convener / Chairman admission committee/ Director@WCE shall be final and binding to all.

13. Cheque and cash payment will not be accepted under any circumstances.

14. After allotment of seat, candidate will be issued an allotment letter duly signed by the Admission Authority.

15. Note: In case parents plan to attend the Institute Level Counselling round in place of student, they have to carry consent/authority letter signed by student along with Aadhar card copies of student and parent attending the counselling round.
